

**GATHER THE GOOD FARM MARKET  
COMMUNITY SUPPORTED AGRICULTURE  
SHAREHOLDER AGREEMENT**

Gather The Good Farm Market LLC ("GTG") has developed a community supported agriculture program ("CSA") designed to provide fresh produce, eggs, meat and other high quality foods and products to its members. The goods provided through the CSA are grown, raised, and harvested on site at Aberlin Springs and from other local and regional providers. A variety of seasonal fresh produce will be available in the Gather the Good Farm Market (the "Market") from May to October, while meat, eggs, and non-perishable items will be available year round.

GTG is committed to using sound and sustainable farming techniques to grow and cultivate the highest quality produce. That said, farming is a seasonal and unpredictable undertaking, which will likely result in fluctuations and variations in both the volume and variety of selections included in the Market throughout the year. In order to help ensure sufficient quantity and assortment of items, the CSA will only be available to residents of Aberlin Springs and others that agree to become members of the CSA.

During produce season (May to October), a weekly email will be sent to each CSA member. This email will provide information about the perishable items that will be available in the Market that week. Depending upon crop availability and projected demand, the Farm Manager will gauge the proper quantities of each produce item to have available in the Market. Additional items from select providers will also be available throughout the year.

In order to participate as a member of the CSA, you hereby agree to the following terms and conditions:

1. You agree to pay the annual membership fee of \$850.00 per household ("Annual Fee") for a one-year membership running from February 1 of the applicable calendar year to January 31 of the following calendar year ("Membership Year"). Payment is due in full no later than January 31 prior to the Membership Year, and shall be payable to: Gather the Good Farm Market, 3472 Snook Rd., Morrow, OH 45152.
2. Once paid, your Market account ("Account") will be credited, and you will be able to make purchases in the Market that will be offset against the balance in your Account.
3. A file with your Account details will be kept at a designated location in the Market. Whenever you would like to make a purchase, you agree to post those items to your Account by following the established procedure for self-checkout.
4. You agree to comply with all self-checkout instructions, and shall complete the process accurately and truthfully.
5. You agree not to purchase any item or combination of items that would exceed the value of your Account.
6. Additional amounts can be added to your Account ("Added Funds") at anytime throughout the year by submitting additional payments to: Gather the Good Farm Market, 3472 Snook Rd., Morrow, OH 45152.
7. Your Annual Fee is non-refundable and no portion shall be carried over into another Membership Year. Any portion of your Annual Fee for the applicable Membership Year that is still remaining in your Account as of 11:59pm EST on January 31 will be forfeited.
8. Added Funds are non-refundable, but any Added Funds in an account at the end of a Membership Year will be carried over to the following Membership Year. If a consecutive membership is not obtained, any Added Funds in the Account will be forfeited as of 11:59pm EST on January 31. Any Added Funds carried over to a new Membership Year will not reduce or otherwise impact the amount of the Annual Fee.
9. The Market is a self-service facility, and you agree to follow all rules and requirements for use and access of the Market, including:
  - a. Maintain the confidentiality of the passcode that is provided to you to enter the Market.
  - b. Do not allow non-members to enter the Market without another member present.
  - c. Only take a reasonable share of any particular produce item unless you have requested a bulk amount by emailing a request to the Farm Manager before 5:00pm EST on the Tuesday prior to pick-up.
  - d. If accessing the refrigerator or freezer, the doors must be tightly closed when finished.
  - e. The door to the Market must be closed securely upon exit.
  - f. The Market will be closed every Thursday until 5:00pm EST in order to harvest and stock produce and other items. Avoid entering the Market during this timeframe and at any other times when the Market is closed.
  - g. Comply with all posted directions and instructions.
  - h. You understand that there is video surveillance of the interior and exterior of the Market at all times, and that video surveillance and recordings may be used in the investigation of security and/or safety related incidents.
  - i. You agree to notify GTG immediately if you have information about any misconduct or wrongdoing related to the Market.
  - j. You hereby release, indemnify, and hold harmless GTG and its affiliates, including their owners, agents, and employees, from any and all claims, damages, and/or liability that may be suffered by you or a member of your household related to the Market, the CSA membership, and the use or consumption of any food or other item provided by or through GTG.
  - k. If you violate any provision of this agreement, you will be considered to be in breach of contract and GTG may terminate this agreement and retain any and all amounts remaining in your Account.

I hereby agree to become a member of the CSA and to be responsible for myself and all others in my household. By signing this agreement, I acknowledge that I have read, understand, and agree to all of terms and conditions of this agreement.
