

**GATHER THE GOOD FARM MARKET
COMMUNITY SUPPORTED AGRICULTURE
SHAREHOLDER AGREEMENT**

Gather The Good Farm Market LLC ("GTG") has developed a community supported agriculture program ("CSA") designed to provide fresh produce and eggs to its members. The goods provided through the CSA are grown, raised, and harvested on site at Aberlin Springs and from other local providers. A variety of seasonal fresh produce and a dozen eggs will be available in the Gather the Good Farm Market (the "Market") CSA weekly pickup from April 20, 2022 through November 4, 2022 with no pick up the weeks of August 8 & 15.(27 weeks total). CSA pickup days will be Wednesday and Friday starting at 4:00. .

GTG is committed to using sound and sustainable farming techniques to grow and cultivate the highest quality produce. That said, farming is a seasonal and unpredictable undertaking, which will likely result in fluctuations and variations in both the volume and variety of selections included in the Market throughout the year. In order to help ensure sufficient quantity and assortment of items, the CSA will only be available to residents of Aberlin Springs and others that agree to become members of the CSA.

During produce season (mid-April through October), a weekly email will be sent to each CSA member. This email will provide information about the perishable items that will be in your CSA bounty that week. Depending upon crop availability and projected demand, there will be additional produce and eggs available in the Market for purchase. Additional items i.e. meat, prepared foods, etc. from select providers will also be available for purchase throughout the year.

In order to participate as a member of the CSA, you hereby agree to the following terms and conditions:

1. You agree to pay the annual membership fee of \$850.00 per household ("Annual Fee") for a one-year membership running from February 1 of the applicable calendar year to January 31 of the following calendar year ("Membership Year"). Payment is due in full no later than January 31 prior to the Membership Year, and shall be payable to: Gather the Good Farm Market, 3472 Snook Rd., Morrow, OH 45152.
2. Once paid you will be able to make purchases in the Market. Additional items available in the market may be purchased with cash, check or credit card..
3. You agree to comply with all self-checkout instructions, and shall complete the process accurately and truthfully.
4. Your Annual Fee is non-refundable and no portion shall be carried over into another Membership Year.
5. The Market is a self-service facility, and you agree to follow all rules and requirements for use and access of the Market, including:
 - a. Maintain the confidentiality of the passcode that is provided to you to enter the Market.
 - b. Do not allow non-members to enter the Market without another member present.
 - c. Only purchase a reasonable share of any particular produce item unless you have requested a bulk amount by communicating a request to the Farm Manager.
 - d. If accessing the refrigerator or freezer, the doors must be tightly closed when finished.
 - e. The door to the Market must be closed securely upon exit.
 - f. Comply with all posted directions and instructions.
 - g. You understand that there is video surveillance of the interior and exterior of the Market at all times, and that video surveillance and recordings may be used in the investigation of security and/or safety related incidents.
 - h. You agree to notify GTG immediately if you have information about any misconduct or wrongdoing related to the Market.
 - i. You hereby release, indemnify, and hold harmless GTG and its affiliates, including their owners, agents, and employees, from any and all claims, damages, and/or liability that may be suffered by you or a member of your household related to the Market, the CSA membership, and the use or consumption of any food or other item provided by or through GTG.
 - j. If you violate any provision of this agreement, you will be considered to be in breach of contract and GTG may terminate this agreement and retain any and all amounts remaining in your Account.

I hereby agree to become a member of the CSA and to be responsible for myself and all others in my household. By signing this agreement, I acknowledge that I have read, understand, and agree to all of terms and conditions of this agreement.
